5. Engagement of Guest Instructor for session 2024-25

As all units of all trade has been filled up for the current session 2024-25, hence total 06 nos. trainers to be engage to manage the class .At present no trainer has been posted out of the 06 trainers at the level of DTE&T ,Odisha and to manage the classes the service of Guest Instructor to be hired on hourly remuneration basis as 02 nos. of Guest Instructor has been approved by the Government on first phase . The committee agreed to engage Guest Instructor basing upon the due procedure approval of next competent authority keeping into allotment of fund by Government.

6. OJT- On Job Training.

As regards OJT, there is a provision of 1600 hours training in a year out of which training as per DGT syllabus for 1200 hours be provided at the ITI Level and rest 400 hours be for near by industry (OJT)/Project work.

7. ROR

As regards ROR of the land in possession (Govt. Land) by the institute ,the chairperson advise the principal to apply before the component authority under ERA 2006 in form "A" for Approval of the same by the DFO Balugaon within the prescribed timeline.
